Dear Drs. Fonseca, Gregory and Brantley:

I am enthusiastically writing a letter on behalf of Dr. [REDACTED], who is an applicant for the Roadmap Scholars Program through LA CaTS. I have known [REDACTED] since she joined the [REDACTED]. [REDACTED] shows great promise as a scholar committed to the [REDACTED]—a public health issue that is particularly relevant to Louisiana where [REDACTED]. I would be eager to partner with [REDACTED] in a mentoring capacity and support her receipt of this fellowship without reservations.

During [REDACTED]'s time at [REDACTED], I have had the opportunity to work closely with her on developing and submitting a large grant through the Robert Wood Johnson Foundation. Through collaboration with the [REDACTED], [REDACTED] and I proposed testing the efficacy of a [REDACTED] to bolster the effects of an evidence-based [REDACTED]. Although ultimately unfunded, I respected the tenacity and attention to detail that [REDACTED] paid in developing this proposal. From this process, I observed [REDACTED]'s commitment to community-engaged research, strong command of the research literature, and her investment in developing rich interdisciplinary partnerships.

I also have worked closely with [REDACTED] on preparing a manuscript for publication in the [REDACTED] journal. I granted [REDACTED] access to one of my qualitative datasets that investigated the contextual factors that inform [REDACTED]'s definitions of [REDACTED].
